CLASS TUITION - TUITION IS DUE THE 1ST CLASS OF EACH MONTH. MONTHLY TUITION IS BASED UPON 4 CLASSES PER MONTH AND WILL BE THE SAME EACH MONTH. TUITION SHOULD BE PLACED IN THE MAILBOX LOCATED IN THE STUDIO LOBBY OR MAILED TO THE ABOVE ADDRESS. NO MONTHLY BILLS ARE SENT. HOWEVER, A \$10.00 LATE FEE WILL BE ADDED TO ANY TUITION RECEIVED AFTER THE 7TH DAY OF THE MONTH. IN THE EVENT YOU R ACCOUND BECOMES MORE THAN 30 DAYS PAST DUE IT MAY BE TURNED OVER TO A COLLECTION AGENCY. IF YOUR ACCOUNT IS NOT PAID IN FULL AND THIS ACCOUNT IS TURNED OVER TO A COLLECTION AGENCY AND/OR ATTORNEY, THEN YOU AGREE TO BE RESPONSIBLE FOR ALL REASONABLE FEES NECESSARY FOR THE COLLECTION OF THE DELINQUENT ACCOUNT INCLUDING BUT NOT LIMITE TO, COLLECTION AGENCY FEES OF 50% OF THE BALANCE DUE AND COSTS AND RESONABLE ATTORNEY'S FEES OF 30% OF THE BALANCE.
